Disclaimer

1. Reimbursements of up to \$15 per month will be made on all ATM fees that were charged via a third party.
2. Early withdrawal fees vary and are based on the terms of the Certificate of Deposit. See the Modern Bank Deposit Account Information brochure, and other account disclosures received at account opening for additional details.
3. Overnight Debit Card Replacement or Issuance is available for \$90.
4. Requests for more than 5 checks may result in Research / Reconciliation fees.
5. If you choose to convert an international transaction to US dollars at either an ATM or a purchase, foreign currency commissions and fees may be included in the exchange rate charged by third parties.
6. Legal processing includes subpoenas, restraining orders, writs of attachment or execution, levies, garnishments, search warrants, or similar orders relating to your account that appear to us to be valid, as well as the handling of these matters. Legal processing fees may also include research fees (in connection with document production, for example) as well as out-of-pocket legal fees, expenses and costs in the event Modern Bank deems it necessary to engage outside legal counsel for any reason in connection with the handling of the matter.
7. Minimum Balance requirements are as follows: Checking Accounts require no minimum balance, interest accruing Checking Accounts require a minimum balance of \$1,000; Savings Account require a minimum balance of \$1,000; High Yield Money Market Accounts require a minimum balance of \$100,000; Certificates of Deposit (CDs) require a minimum balance of \$1,000.
8. All Bank Checks have a base fee of \$20. An additional \$10 fee will be applied for shipping.
9. Modern Bank processes foreign currency wires through JP Morgan Chase, and exchange rates are the prevailing exchange rates provided by JP Morgan Chase.

This fee schedule applies to all Modern Bank accounts. Fees for your account may be different than those listed in this schedule based on overall relationship with us and additional fees may apply depending on how you use your account. For additional terms and conditions that apply to your account, please see the Modern Bank Deposit Account Agreement.

If there is a legal action, or if there is a legal dispute involving your account, you agree to pay us our reasonable attorneys' fees, legal expenses and costs, if allowed by law. This includes those fees, expenses and costs on any appeal. You also agree that we may deduct all of the fees, expenses and costs from your account.

This schedule lists account fees that may apply to you, fees may vary depending on which account you have, how you use your account and what services you use. For information about interest rates, fees and other services not covered in the schedule, please contact a Modern Bank Service Officer at (212) 323-1100.

Please note, fees for your account may vary from those listed in this schedule based on your overall relationship with us.

Fees may be waived based in certain circumstances.
