You will be notified of any changes in accordance with the terms and conditions set forth in our Depositor's Agreement. Please note that fees for your account may be different than those listed in this Schedule of Fees based on your overall relationship with us. For wire transfers you send or we receive in a foreign currency, the exchange rate is determined by us in our sole discretion and will include a spread, which we may make a commission from when completing the foreign currency exchange. You should expect that these foreign exchange rates will be less favorable than rates quoted online or in publications. Overdraft: MBG pays a transaction during our nightly processing on a business day when your account balance is overdrawn.

We won't charge an Overdraft Fee:

Overdraft Fees

- If your debit card transaction was authorized when there was a sufficient available balance in your account
- If your check or ACH is returned unpaid. However, we may charge an Overdraft Fee if a previously returned check or ACH is presented again and paid.
- If your debit card transaction or ATM cash withdrawal request is declined.

\$34 Overdraft Fee per transaction during our nightly processing beginning with the first transaction that overdraws your account balance.

 Maximum of 6 fees per business day (up to \$204)

You can avoid overdrawing your account by making a deposit or transferring funds to cover the overdraft before the business day ends and we start our nightly processing. If you have multiple accounts with us, contact one of our service representatives about setting up an end of day overdraft coverage sweep. - When transferring money on online at modernbank.com or MBG Mobile before 6:00pm ET


